- 2 will be liable for any costs arising from any irresponsible or unlawful acts;
- 3 will be liable for any damage to the Guernsey Badminton Association property through irresponsible behaviour or the wearing of incorrect footwear (NB non-marking footwear to be worn);
- 4 agrees to receiving medication as instructed and any emergency dental, medical or surgical treatment, including anaesthetic or blood transfusion, as considered necessary by medical authorities present;
- 5 accepts that there is no Guernsey En Garde medical insurance and understands the extent and limitations of the BRITISH FENCING insurance cover and that a copy of the policy is available at [www.britishfencing.com](http://www.britishfencing.com);
- 6 accepts liability for all costs arising from the instructions given to maintain the health and well-being of myself or my child (whichever is applicable) by representatives of Guernsey En Garde.
